It is also understood that this agreement may serve as the basis Specific further agreements to be developed at a later date. It is further understood that either institution may terminate the agreement at any time, upon One-year written notification to the partner institution, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to either party.
