

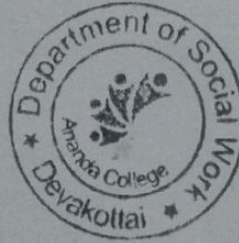
The Specific objectives for this MOU are as follows :

7. To utilize the resources available in the Library of both the Institutions for the benefit of scholars, students and Faculty.



MEMORANDUM OF UNDERSTANDING

Department of Commerce with Computer Applications, J.J. College of Arts and Science (Autonomous), Sivapuram (Po), Pudukkottai (Dt) – 622 422, Tamil Nadu, India and Department of Commerce, Ganesar College of Arts and Science, Melaisivapuri, Pudukkottai (Dt) – 622 403, Tamil Nadu, India hereby enter into this General Agreement to foster Institutional Cooperation in Education and Research.

1. Both Parties agree to encourage the following exchange activities based on their respective academic and educational needs.

- a. Exchange of Scholars
 - b. Exchange of Students
 - c. Exchange of Research facilities
 - d. Conduct Value Added Course
 - e. Joint Conferences/Workshops
 - f. Joint Online Programs
 - g. Exchange of Facilities
 - h. Other Academic exchange Programme
- as may be agreed to by both the parties from time to time

2. The implementation of each exchange program referred above will follow the guidelines established on mutual agreement by both the parties. Efforts will be made by both the parties to find financial resources for carrying out the activities listed above.

3. Nothing shall diminish the full autonomy of either institution nor will any constraints be imposed by either upon the other in carrying out the agreement.

4. This agreement shall be in force for a period of FIVE YEARS from the date of signing and is subject to revision or modification by mutual consent. It is also understood that this agreement may serve as the basis for specific further agreements to be developed at a later date. It is further understood that either institution may terminate the agreement at any time, upon One-year written notification to the partner institution, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to either party.
