CONDITIONS OF PROVISIONAL AFFILIATION:

01. Each and every one of the recommendations of the Commission should be implemented (Copy of the Inspection Report is enclosed).
02. The College should have permanent buildings and accommodations should be made available for the conduct of the proposed new course.
03. The maximum number of students that may be admitted to the course should not exceed the sanctioned strength of 60 (Sixty)
04. Excess admission should not be made to any course over and above the sanctioned strength of the respective course.
05. Library/Laboratory should be strengthened as suggested by the Inspection Commission.
06. All the text books and reference books as prescribed in the syllabus for the above course be obtained and stacked in the library (minimum 5 copies each).
07. The staff as recommended by the Commission should be appointed in time, subject to the stipulations of the University.
08. Arrangements should be made for the conduct of the University examinations for this course also.
09. An agreement should be entered into with the teachers already appointed as per the requirements of the University / Tamil Nadu Private College (Regulations) Act 1976, as applicable.
10. The College should not obtain donations from students seeking admission to any course of study in the College.
11. All the vacant posts should be filled up with qualified persons before the commencement of the ensuing academic year. The post of the Professors / Heads of Departments wherever required for the new course now granted affiliation should also be filled up before the commencement of the course and the approval of qualifications should be obtained from the University.
12. The extension of provisional affiliation for the above course should be obtained from the University before admission of students in the course is made for the subsequent academic years.
13. The minimum teaching hours for evening section classes for each Semester is to be fixed as 450 hours or 25 hours per week; this can be reached by having a minimum of 3 hours per day in between 2.00 p.m. and 9.00 p.m. on all the five days in a week and full-day classes on Saturdays and Sundays wherever necessary.



14. *Proper lighting arrangements for class rooms, library and bathrooms shall be made.*
15. *The work of the Day College staff whose services are being utilized for the evening section classes on a part-time basis should be arranged in such a way that they are not requested to remain in the College for more than six hours a day and are assigned work in two consecutive sessions. The total number of hours assigned to take teachers should be within the maximum limits per week as stipulated by the Commissioner of Collegiate Education, Chennai.*
16. *The College shall collect from the students and remit to the University in time registration fee, matriculation fee, recognition fee, fee for infra-structural facilities, sports fee, cultural fee, examination fee, fee for condonation of attendance and any other fees as any other fees as may be prescribed by the University from time to time.*
17. *In the case of any management's of a College (i) not fulfilling any or all the conditions prescribed for affiliation, recognition or approval or (ii) not complying with any or all the rules of the University or (iii) not implementing any decision of the Syndicate, it shall be competent for the Syndicate -*
- *to suspend the provisional affiliation, recognition or approval granted to the College in any course or courses of studies;*
 - *to reduce the sanctioned strength of any course or courses of studies;*
 - *to decline to entertain any new application for additional affiliation or approval or recognition or application for increase in strength in courses of studies conducted in the College;*
 - *to withdraw the permanent affiliation or approval or recognition granted to the College in any or all the courses of studies in which instruction is offered in the College.*
 - *to decline to forward to the U.G.C. any application made by the management for sanction of any grant.*
18. A Review Committee (preferably with the same member) shall be sent by the University in between November 2018 and January 2019 (i) to review the fulfillment of the above conditions prescribed by the Commission while recommending for provisional affiliation for the above Course for the academic year 2018-2019 and (ii) to recommended for extension of provisional affiliation for the above Course for the year 2019-2020.

19. The University shall suspend affiliation to any of the courses for which the affiliation conditions have not been fulfilled and that no further affiliation shall be granted in future.
20. Such other conditions as may be prescribed by the University from time to time should also be complied with by the College.

The University reserves the right to send a Review Committee to verify the fulfillment of any or all conditions as stipulated by the University in this provisional affiliation orders.

In communicating the above, I am to request you to kindly forward to this office within a week an undertaking to the effect (a) that the Management of the College will implement each and every one of the recommendations of the Inspection Commission and fulfill all the conditions enumerated above and (b) that the Management of the College will not collect capitation fee in any form from the students seeking admission in the College (as required in the Clause (V) of the Chapter XIV of Bharathidasan University Statutes).





I am, by direction, to inform you that in consideration of the reports of the Inspection Commission appointed by the University to your College in connection with your application cited for grant of provisional affiliation to start new programme viz., B.Sc. Fashion Technology & Costume Designing. it has been decided that provisional affiliation to B.Sc. Fashion Technology & Costume Designing. programme with an intake of 40 (Forty) students only is granted to your College from the academic year 2022-2023, subject to the implementation of the recommendations of the Inspection Commission and also subject to the fulfillment of each and every one of the following conditions of affiliation.

The students who are admitted to the above mentioned programmes during 2022-2023 shall be permitted to write their first semester examination after completion of 90 working days and second semester examination after completion of another 90 working days and subsequent examinations continuously.

Specific recommendations of the Commission.

- (ii) Two qualified staff should be appointed before the next academic year. (08ஆ)
(ii) Books and furniture as recommended by the Commission be procured for Rs.10,000/-every year (09ஈ)

CONDITIONS OF PROVISIONAL AFFILIATION:

01. Each and every one of the recommendations of the Commission should be implemented (Copy of the Inspection Report is enclosed).
02. The College should have permanent buildings and accommodations should be made available for the conduct of the proposed new programme.
03. The maximum number of students that may be admitted to the programme should not exceed the sanctioned strength of 40 (Forty).
04. Excess admission should not be made to any programme over and above the sanctioned strength of the respective programme.
05. Library/Laboratory should be strengthened as suggested by the Inspection Commission.
06. All the text books and reference books as prescribed in the syllabus for the above programme be obtained and stacked in the library (minimum 5 copies each).
07. The staff as recommended by the Commission should be appointed in time, subject to the stipulations of the University.
08. Arrangements should be made for the conduct of the University examinations for this programme also.
09. An agreement should be entered into with the teachers already appointed as per the requirements of the University / Tamil Nadu Private College (Regulations) Act 1976, as applicable.
10. The College should not obtain donations from students seeking admission to any programme of study in the College.
11. All the vacant posts should be filled up with qualified persons before the commencement of the ensuing academic year. The post of the Professors / Heads of Departments wherever required for the new programme now granted affiliation should also be filled up before the commencement of the course and the approval of qualifications should be obtained from the University.
12. The extension of provisional affiliation for the above programme should be obtained from the University before admission of students in the course is made for the subsequent academic years.
13. The minimum teaching hours for evening section classes for each Semester is to be fixed as 450 hours or 25 hours per week; this can be reached by having a minimum of 3 hours per day in between 2.00 p.m. and 9.00 p.m. on all the five days in a week and full-day classes on Saturdays and Sundays wherever necessary.

14. Proper lighting arrangements for class rooms, library and bathrooms shall be made.
15. The work of the Day College staff whose services are being utilized for the evening section classes on a part-time basis should be arranged in such a way that they are not requested to remain in the College for more than six hours a day and are assigned work in two consecutive sessions. The total number of hours assigned to take teachers should be within the maximum limits per week as stipulated by the Commissioner of Collegiate Education, Chennai.
16. The College shall collect from the students and remit to the University in time registration fee, matriculation fee, recognition fee, fee for infra-structural facilities, sports fee, cultural fee, examination fee, fee for condonation of attendance and any other fees as any other fees as may be prescribed by the University from time to time.
17. In the case of any management's of a College (i) not fulfilling any or all the conditions prescribed for affiliation, recognition or approval or (ii) not complying with any or all the rules of the University or (iii) not implementing any decision of the Syndicate, it shall be competent for the Syndicate -
 - to suspend the provisional affiliation, recognition or approval granted to the College in any programme or programmes of studies;
 - to reduce the sanctioned strength of any programme or programmes of studies;
 - to decline to entertain any new application for additional affiliation or approval or recognition or application for increase in strength in programmes of studies conducted in the College;
 - to withdraw the permanent affiliation or approval or recognition granted to the College in any or all the programmes of studies in which instruction is offered in the College.
 - to decline to forward to the U.G.C. any application made by the management for sanction of any grant.
18. A review Committee (preferable with the same member) shall be sent by the University in between January 2023 and February 2023 (i) to review the fulfillment of the above conditions prescribed by the Commission while recommending for provisional affiliation for the above programme for the academic year 2022-2023 and (ii) to recommended for extension of provisional affiliation for the above programme for the year 2023-2024.
19. This order is issued subject to the approval of the Syndicate and fulfillment of the conditions stipulated by the Syndicate if any.
20. The University shall suspend affiliation to any of the programmes for which the affiliation conditions have not been fulfilled and that no further affiliation shall be granted in future.
21. Such other conditions as may be prescribed by the University from time to time should also be complied with by the College.


